A:General Terms and conditions:

1. The successful bidder will deposit the **performance security in lumpsum Rs.20,000/-** in shape of separate demand draft/FD of any nationalized bank drawn in favour of **ICAR CSWRI** payable at **SBI, Malpura** within the stipulated date falling which the order will be stand cancelled and the EMD deposited with the quotation/tender will be forfeited.
2. The security deposit shall be forfeited if the selected firm/contractor does not take up and/or complete the work within the time schedule or the quality of the workmanship is found not up to the mark or not satisfactory.
3. Any dispute in this regard is subject to Malpura Jurisdiction only.
4. Income Tax/ Labour Cess etc. or any other taxes to be levied as per Govt. norms will be deducted '**at source**' from the bills as per rules.
5. **Locations for the Work**

The entire works as described in Schedule of Requirements must be undertaken at CSWRI Avikanagar, Malpura, Distt; Tonk

6. **Order Placements:**

8. Amendment to Bidding Documents

- a. At any time prior to the deadline for submission of bids, ICAR-CSWRI may, for any reason, whether on its own initiative or in response to the clarification request by a prospective bidder, modify the bid document.
- b. The amendments to the tender documents, if any, will be notified by release of Corrigendum Notice in print media / website. The amendments/ modifications will be binding on the bidders.
- c. ICAR-CSWRI, at its discretion may extend the deadline for the submission of bids if it thinks necessary to do so or if the bid document undergoes changes during the bidding period, in order to give prospective bidders time to take into consideration the amendments while preparing their bids.

The Bid documents shall be neatly arranged. They should not contain any terms and conditions, printed or otherwise, which are not applicable to the Bid. The conditional bid will be summarily rejected. Insertions, postscripts, additions and alterations shall not be recognized, unless confirmed by bidder's signature.

A lump sum amount of Rs. 10,000/- which may be furnished in the form of Insurance Surety Bonds/ Account Payee Demand Draft, Fixed Deposit Receipt, from a commercial bank, Bank Guarantee, from a commercial bank or online payment through RTGS / internet banking

11. Deadline for Submission of Bids – Online Only.

- a. Bids must be received by ICAR-CSWRI before the due date and time at the address specified in the tender document.
- b. ICAR-CSWRI may extend this deadline for submission of bids by amending the bid documents and the same shall be suitably notified in the media.

12. Late Bids

ICAR-CSWRI shall not be responsible and liable for the delay in receiving the bid for what so ever reason.

Bid Opening & Evaluation of Bids

- a. The technical bids will be evaluated in two steps.
- b. The bids will be examined based on eligibility criteria as stipulated to shortlist the eligible bidders.
- c. The technical bids of only the short listed eligible bidders shall be evaluated based on technical specifications stipulated.

13. Comparison of Bids

- a. Only the short-listed bids from the bid evaluation shall be considered for commercial comparison.
- b. The commercial bids will be evaluated on the basis of prices quoted. The contract will be awarded to lowest evaluated bidder.
- c. The total of quoted price for all items will be taken into consideration for evaluation of lowest bidder.

14. Award of Contract

- a. ICAR-CSWRI shall award the contract to the eligible bidder whose technical bid has been accepted and determined as the lowest evaluated commercial bid.
- b. ICAR-CSWRI reserves the right to increase or reduce the quantity of work.
- c. If more than one bidder happens to quote the same lowest price, the firm have been more experience will be awarded the work and if experience of both firm remains same, ICAR-CSWRI reserves the right to decide the criteria and further process for awarding the contract, decision of ICAR-CSWRI shall be final for awarding the contract.

15. Purchaser's Right to amend / cancel.

- i. ICAR-CSWRI reserves the right to amend the eligibility criteria, commercial terms & conditions, Scope of Work, technical specifications etc.
- ii. ICAR-CSWRI reserves the right to cancel the entire tender without assigning any reasons thereof.

16. SPECIAL CONDITIONS OF CONTRACT (SCC)

Prices

- The price quoted shall be considered and no price escalation will be permitted.
- The prices quoted must be inclusive of all other taxes/levy including GST.

Security Deposit (SD):

The successful bidder will be required to furnish the Security Deposit in INR amount of Rs. 20,000/- which may be furnished within 7 days of receipt of Contract/Work order. The Security Deposit should be submitted in the form of Account Payee Demand Draft/Fixed Deposit from a Nationalised bank, Bank Guarantee, from a Nationalised bank or online payment through RTGS / internet banking drawn in favour of ICAR CSWRI payable at SBI, Malpura. The Security Deposit will be retained for 60 days beyond the contract period and will be returned after successful completion of all contractual obligations.

Payments:

Payment will be made after 100% completion of the work on actual measured quantity basis and acceptance by ICAR-CSWRI, through NEFT.

Penalty for delayed Completion of the works:

ICAR-CSWRI reserves the right to levy penalty @ of 0.5% of order value per week of delay beyond the scheduled date completion / execution of the order successfully, subject to maximum of 05 % of the order value. ICAR-CSWRI reserves the right to cancel the order in case the delay is more than 4 weeks.

B: Other General Terms and conditions:

1. After completion of work if within one month, any defect, or damage or poor workmanship is noticed; the same shall be rectified by the contractor within 10 days failing which the Security deposit shall be forfeited.
2. Taxes viz. Income Tax, Cess on I.T., Labour Cess, (as per applicable) and such other taxes levied by Government from time to time will be deducted from the work bill, Labour cess @ 1% of the gross value of work to be deducted from the contracts bill and to be remitted to the 'Avikanagar Building and other Construction Workers' Welfare Fund".
3. Payment will be made after 100% completion of the work on actual measured quantity basis and acceptance by ICAR-CSWRI, through NEFT/RTGS/e-Payment.
4. No part payment will be made for execution of the work.
5. Contract/Work order will be issued to the successful bidder after completion of all formalities of ICAR-CSWRI Avikanagar. The successful bidder has to enter an agreement after receipt of Contract/work order and before start of the work. If the bidder does not start the work within 7 days of issue of work order or does not represent to the Director, ICAR-CSWRI Avikanagar stating a valid reason such as interference of natural phenomena or the circumstances beyond his control, the work order shall be deemed to be withdrawn without any notice and suitable action against the firm as per the provision of bid security declaration will be taken. Decision of the ICAR-CSWRI Avikanagar in this regard is final and binding on the tenderer.
6. Rates quoted by the bidder will be valid till for one year.
7. In case the contract/work order is placed for execution, it will be incumbent on the tendered to abide these terms and conditions and complete the work as per the schedule of works to the best satisfaction of the Work committee/In-Charge, Estate Section failing which the EMD will be forfeited and the tendered is liable to pay the loss to be incurred by ICAR-CSWRI, to carry out the work/balance of work through any other agency.
8. If any damage occurs to ICAR - CSWRI property during execution of work including dismantling the same will be borne/repaid by the tendered. For this reason, the tendered is advised to inspect the work site before submitting the tender.
9. Director, ICAR-CSWRI is not bound to accept the lowest or any other tender and also reserves the right to reject any or all the quotations without assigning any reason thereof.
10. The tendered will be abide by the contract labour act, minimum wages act and other labour related acts, applicable during execution of the work.
11. The workers will be personnel of the tendered and ICAR-CSWRI will have no responsibility whatsoever to them. Any liability that may arise due to death/injury to any of the workers while executing the work will be borne by the tendered.
12. In case of any dispute on execution or other issues related to this work, the decision of the Director, ICAR-CSWRI will be final and binding.
13. Successful bidders will have to enter into a detailed contract agreement (format attached) with ICAR-CSWRI on non-judicial stamp paper of Rs.500/- (Rupees Five hundred only).

नियम एवं शर्तें:

1. अनुबन्ध की अवधि एक वर्ष के लिये होगी। इस अवधि के दौरान अनुबन्धकर्ता का कार्य सन्तोषजनक होने की स्थिति में अनुबन्ध को बढ़ाया जा सकता है।
2. कार्य शिड्यूल में दी गयी विशिष्टियों के अनुसार करना होगा।
3. कार्य के उपयोग में आने वाली सामग्री जैसे पेंट, प्लास्टिक ईमलसन, डिस्टेम्पर, प्राईमर बिरला ब्रान्ड अथवा) पट्टी एवं अन्य सामान (एशियन ब्रान्ड अथवा बर्जर ब्रान्ड) का होना चाहिये।
4. रंगरोगन करने से पूर्व किये जाने वाले रंग, प्राईमर इत्यादि कि जानकारी प्राप्त कर कार्य हेतु रंग, प्राईमर इत्यादि लाना होगा एवं कार्य प्रारम्भ करने से पूर्व सामान प्रभारी सम्पदा प्रतिनिधि को दिखाने के पश्चात् ही कार्य प्रारम्भ करना होगा।
5. कार्य के दौरान उपयोग में आने वाले सामान जैसे सीढ़ी, पेडा बांधने एवं अन्य सामान की व्यवस्था अनुबन्धकर्ता को ही करनी होगी।
6. कार्य के दौरान लगाए गए श्रमिक प्रशिक्षित व अनुभवी होने चाहिए।
7. कार्य समाप्ती पर प्रभारी सम्पदा अनुभाग प्रतिनिधि के समक्ष किए गए कार्य का माप करवाना होगा।

12. आवासीय/गैर आवासीय भवन की सफाई की जिम्मेदारी अनुबन्धकर्ता की होगी। रंग अथवा अन्य किसी प्रकार का दाग – रंगरोगन के पश्चात् साफ करना होगा। कार्यालय भवन अथवा अन्य स्थान पर रंग/धब्बा-नहीं रहना चाहिये ऐसा पाये जाने पर उसको साफ करवाने की खर्च की राशि अथवा रु. 1000/- मात्र की कटौती अनुबन्धकर्ता देय बिल में (जो भी अधिक हो) से कटौती की जा सकती है।
13. अनुबन्ध की अवधि के दौरान ठेकेदार एवं उनके प्रतिनिधियों द्वारा संस्थान के कर्मचारियों अधिकारियों के साथ शिष्टता का व्यवहार करना होगा।

16. ठेकेदार को अनुबन्ध की अवधि में भारत सरकार के प्रचलित श्रमिक कानूनों का पालन करना होगा। भारत सरकार द्वारा न्यूनतम मजदूरी अधिनियम के तहत समय-2 पर निर्धारित दर से भुगतान करने की जिम्मेदारी स्वयं ठेकेदार की होगी। साथ ही बाल श्रमिक कानून का पूर्ण पालन करना होगा।
17. ठेकेदार द्वारा जिन प्रतिनिधियों को अनुबन्ध कार्य हेतु नियुक्त किया जावेगा, उनका फोटो युक्त परिचय पत्र ठेकेदार द्वारा अधिकृति सुरक्षा अधिकारी से बनवाकर प्रभारी सम्पदा अनुभाग को प्रस्तुत करना होगा जिसका व्यव स्वयं ठेकेदार को वहन करना होगा। साथ ही प्रतिनिधियों का नाम, पता व मोबाईल नम्बर इत्यादि प्रभारी को उपलब्ध कराना होगा।
18. अनुबन्ध कार्य के दौरान किसी प्रकार की दुर्घटना हो जाने पर ठेकेदार उनके प्रतिनिधि स्वयं जिम्मेदार होंगे तथा सभी प्रकार की कानूनी कार्यवाही अपने स्तर पर स्वयं के खर्च पर करनी होगी। संस्थान द्वारा किसी भी प्रकार की सहायता / क्षतिपूर्ति राशि नहीं दी जावेगी। अतः अनुबन्धकर्ता अनुबन्ध मिलने के साथ ही उसके अधीन कार्य करने वाले सभी कर्मिकों का बीमा अवश्य करवा लें।

20. श्रमिक नियमों के अनुसार समस्त अभिलेख ठेकेदार को तैयार कराना होगा तथा सम्बन्धित अधिकारी द्वारा मॉगने पर प्रस्तुत करना होगा।
21. सभी विवादों को निपटाने का क्षेत्राधिकार अविकानगर, मालपुरा होगा। किसी भी प्रकार का विवाद होने की स्थिति में अन्तिम निर्णय का अधिकार निदेशक केन्द्रीय भेड़ व उन अनुसंधान संस्थान, अविकानगर, तहसील मालपुरा, जिला टोंक, राजस्थान का होगा। जिसे एजेन्सी/फर्म/ठेकेदार द्वारा मान्य होगी।
