GENERAL INSTRUCTIONS

Procedure for Submission of e-Tenders/Bids

The bidders require to submit their bids through Central Public Procurement Portal - (CPPP) <https://eprocure.gov.in/eprocure/app> under two bid system i.e.

- i) **Technical Bid** and
- ii) **BOQ./Financial Bid Form(Annexure D)**

Technical Bid: -

Mandatory Documents

The following documents must be uploaded for Technical bid

1. **Demand Draft for EMD of Rs. 80000/-(Refundable).**
2. **Valid Trade License Certificate**
3. **GST Registration certificate**
4. **Copy of PAN/TAN Card**
5. **Copies of Work Orders (PO) and Completion Certificates (CC) of Timber Auction for any government/PSU organizations.**
6. **Signed Undertaking (as in Annexure III)**

Bids received and found valid will be evaluated by CSWRI to ascertain the best evaluated bid for the complete work/services under the specifications and documents. The bidder should take care to submit all the information sought by CSWRI in prescribed formats. Incomplete, conditional, telephonic bids or tender uploaded after due date & time will not be considered and will be summarily rejected.

Financial Bid: -

1. Those bidders who have qualified in technical bid shall be entertained for the financial bid. The financial bid format is provided as BOQ along with this tender document at <https://eprocure.gov.in/eprocure/app>. Bidders are advised to download this BOQ as it is and quote their Final amount including tax and other incidental charges for Cutting off of Perilous Trees, Uprooted Trees and Wood Pieces at CSWRI Office and Quarters Compound, Puthur in the permitted column and upload the same in the financial bid. Bidder shall not tamper/ modify downloaded price bid template (BOQ) in any manner. In case if the same is found to be tampered/modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to be banned. Financial bid will be evaluated as per amount quoted by the bidders. Thus a bid which is substantially responsive and quotes Maximum Amount shall be ranked as H-1 and so on. In case, quoting same Amount by more than one bidder, the selection of H-1 agency will be made on the basis of minimum time limit for cutting and clearing the woods from the compound.
2. Bidders are also advised to submit Financial Bid in Annexure D Form duly filled by quoting the bid amount (In Indian Rupees Only).

3. PERIOD FOR WHICH THE OFFER WILL REMAIN OPEN AND PERIOD OF VALIDITY.

- i) All tenders should remain valid for acceptance for a period of Six months or completing the work, whichever is earlier, from the date of opening of the tender.
- ii) Quotations qualified by such vague and indefinite expressions such as “subject to immediate acceptance, “subject to prior work” etc. will not be considered.

4. BID SECURITY/ EARNEST MONEY:

The tenderer shall have to deposit money of **Rs.80000/-** (Refundable) with their Technical Bid at the time of application, failing which the tender shall be rejected. The earnest money is to be paid by Demand Draft drawn in favour of **ICAR UNIT CSWRI, MALPURA**. Payment online through RTGS / internet banking in the name **ICAR UNIT CSWRI Account No. 51066000084 IFSC Code SBIN0031088**, Bank Name SBI Branch Malpura **NO CHEQUES OR CASH WILL BE ACCEPTED**. In the event of the withdrawal/ revocation of tenders before the date specified for acceptance, the earnest money shall stand forfeited. Earnest Money Deposit (EMD) to be sent by post/ delivered in hand to the Director ICAR CSWRI Avikanagar before **07/05/2024, 03:00 PM** . Successful tenderers’ earnest money will be returned without any interest, after receipt of performance security from that tenderer. Earnest money furnished by all the unsuccessful tenderers shall be returned to them without any interest whatsoever, at the earliest after expiry of the final tender validity period but not later than 30 days after finalization of the contract.

SUBMISSION OF BIDS

Bidders participating in online e-tender has to upload the complete Tender documents complete in all its pages along with all the Annexures duly signed and sealed online and has to submit only the EMD in the Tender Box kept at Purchase Section, CSWRI, Avikanagar

Those bidders who are submitting Offline Bids only are required to submit the entire tender document along with all the Annexures(A, B,C) duly filled, signed and sealed along with EMD in one cover and duly filled Financial Bid (Annexure D) signed and sealed in the second cover

5. OPENING OF TENDER:

The tenders shall be opened at the specified date and time and at the specified place as indicated in the TENDER DOCUMENT. In case the specified date of tender opening falls on/ is subsequently declared a holiday or closed day for the purchaser, the tenders will be opened at the appointed time and place on the next working day.

The TECHNICAL BIDS are to be opened in the first instance. These Tenders shall be scrutinized and evaluated by the competent committee/ authority with reference to parameters prescribed in the TENDER DOCUMENT. During the TECHNICAL BID opening, the tender opening committee will read the salient features of the tenders like brief description of the goods offered, delivery period, Earnest Money Deposit and any other special features of the tenders, as deemed fit by the tender opening committee. Competent authority may call the tenderer for demonstration of technical specification. Thereafter in the second stage, the Financial Bid of only the technically qualified tenders shall be opened at a later date which will be notified to such tenderers.

6. PRICES

- i) Prices are to be quoted in Indian Rupees only.

- ii) Prices quoted must be meaningful and measurable/per qtls. in the context.
- iii) Tenderers should clearly specify whether prices quoted are inclusive of GST / statutory charges or such charges as extra. Where no specific mention is made to GST/ or other duties, prices quoted shall be deemed to be inclusive of such taxes/charges.
- iv) The tenderer has to remit GST, Forest Development Tax(FDT) and TDS as fixed by the government from time to time.
- v) After the award of the tender, the successful tenderer has to remit a lump sum amount Rs.8,00,000/- (Rupees Eight Lakh Only) online through RTGS / internet banking in the name **ICAR UNIT CSWRI** Account No. 51066000084 IFSC Code SBIN0031088, Bank Name SBI Branch Malpura

7. NOTIFICATION OF AWARD

Before expiry of the tender validity period, the tender inviting authority will notify the successful tender(s) in writing by registered/ speed post that its tender has been accepted, also briefly indicating there in the essential details like description, specification and quantity of the goods & services and corresponding prices.

8. SECURITY DEPOSIT / PERFORMANCE SECURITY

On acceptance of the tender, within one week, the successful tenderer/contractor shall deposit a sum of Rs.2,00,000/- (Rupees Two Lakh Only), as security deposit, for due compliance & fulfilment of the terms and conditions of the contract. This has to be in the form of a demand draft, drawn on any of the nationalized bank, in favor of **ICAR UNIT CSWRI**, payable at SBI Branch Malpura. **NO CHEQUES WILL BE ACCEPTED** for this purpose. On due performance and successful completion of the contract in all respects, the security money deposit shall be returned to the contractor without any interest. No Demand Certificate in the prescribed form and upon return in good condition of any other property belonging to the purchaser, which may have been issued to the contractor. If the contractor fails to do so, such failure will constitute a breach of the contract and the Director shall be entitled to make other arrangements at the risk and expense of the contractor. Also, non performance/ unsatisfactory performance or violation of terms and conditions of the contract will make the contractor liable for forfeiture of security deposit. Then decision of the Director shall be final and binding on this count. After one month of satisfactory completion of work the tenderer can contact the ICAR-Central Sheep and Wool Research Institute, for the security deposit.

9. WORKING TERMS

- a. Time and date of Execution:- The time and date for work as stipulated in the schedule shall be deemed to be the essence of contract and work must be completed not later than the date(s) specified. The execution of work is required to be completed within a period of 90 days from the date of permission for the work.
- b. The tenderer shall execute the work at the destination without making any inconvenience to the staff and other people visiting the office and dispensary and also not hampering any buildings or goods within the compound within the limits of the time.
- c. When a work order is placed to the successful tenderer, he shall have to acknowledge the receipt of the said order along with DD for Security Deposit within 7 days of the issue.

10. PAYMENT OF AMOUNT

- a. The successful bidder is required to make payment of a lump sum amount **Rs. 8 Lakh** {Earnest money as per rule 220 (iv) of GFR-2017}, before commencement of the work.
- b. Before loading the pruned /chopped off part of trees into loading vehicle, weight of

such loading vehicle shall be measured in unloaded position on institute's dharamkanta. After loading the pruned /chopped off part of trees, the weight shall be measured again and the full payment of such weight of pruned /chopped off part of trees will have to be made in online mode after which gate pass shall be issued.

- c. On receipt of the full amount, ICAR-CSWRI Avikanagar shall issue a letter of permission to the tenderer, allowing to start the work which has to be completed within 90 days from the date of permission or within the period as extended by the competent authority.
- d. For releasing Security Deposit the tenderer will have to produce 'satisfactory work completion certificate' from the ICAR-CSWRI Avikanagar.
- e. Payment of Security Deposit shall be made through Electronic Clearing System(ECS).

10. OTHER TERMS

Responsibility for executing contract:

The contractor/ successful bidder would be entirely responsible for the execution of the contract in all respects in accordance with the terms and conditions as specified in the acceptance of tender. The contractor has to execute an agreement with the Director ICAR-CSWRI Avikanagar in stamp paper worth Rs. 500/- (Rupees five Hundred Only) as per the terms and conditions mentioned in Annexure B

The Contractor shall not sublet/ transfer/ assign the contract or any part thereof without the written permission of the Director ICAR-CSWRI Avikanagar. In the event of the contractor contravening this condition, Director ICAR-CSWRI Avikanagar shall forfeit the Security deposit and immediately cancel the contract. The loss thus incurred to the contractor shall be his liability.

Recovery of sums due: Whenever any claim for the payment of a sum of money arises out of or under this contract against the contractor the ICAR-CSWRI shall be entitled to recovery of such sum by appropriating, in part or whole the security / earnest money deposited by the contractor, when the balance or the total sum to be recoverable, as the case may be shall be deducted from any sum then due or which at any time thereafter may become due under this or any other contract with the ICAR-CSWRI. Should this sum not be sufficient to cover the full amount recoverable, the contractor shall pay to the ICAR-CSWRI on demand the remaining balance due.

Insolvency and Breach of Contract: The Director ICAR-CSWRI Avikanagar may at any time by notice in writing summarily terminate the contract without compensation to the contractor in any of the following events, that is to say:-

- a. If the contractor being an individual or if firm, any partner in the contractor's firm shall at any time be adjudged insolvent or shall have a receiving order or orders for administration of his estate made against him or shall take any proceedings for liquidation or composition under any insolvency not for the time being in force or shall make any assignment or arrangement of his efforts or enter into any arrangement or composition with his creditors or suspend payment of bill if the firm be dissolved under Partnership Act.
- b. If the contractor being a company shall pass a resolution or court shall make an order for the liquidation of the affairs or a receiver or a manager on behalf of the debenture holder shall be appointed or circumstances shall have arisen which

- entitle the court or debenture holders to appoint a receiver or manager, or
- c. If the contractor commits any breach of this contract not herein specifically provided for: Provided always that such determination shall not prejudice any right of action or remedy which have accrued or shall accrue thereafter to the purchaser and provided also that the contractor shall be liable to pay the purchaser for any extra expenditure, he is thereby put to, but shall not be entitled to any gain on goods & services.

Arbitration: In the event of any question, dispute or difference arising out of the terms and conditions listed down in this tender, the same shall be referred to Arbitrator appointed by The Director ICAR-CSWRI Avikanagar The procedure of the Arbitration will be governed by the provisions of Arbitration Act 1940 (as amended from time to time and rules framed there under)

Document: The tenderer should have a valid Trade license, PAN/ TAN/ GST Registration/ other statutory documents as applicable and produce attested copies of such certificates along with the tender papers in Technical Bid, failing on which the tender shall liable to be rejected.

Right to accept/ reject: Director ICAR-CSWRI Avikanagar reserves the right to reject any or all tenders without assigning any reason whatsoever. Also, the office authority reserves the right to award any or part or full contract to any successful agency at its discretion and this will be binding on the tenders.

The quantity shown in the tender can be increased or decreased by Director CSWRI Avikanagar to any extent depending upon the actual requirement.

Assistance to contractor: The contractor shall not be entitled to assistance either, in the procurement of raw materials required for the fulfillment of the contract or in the securing of transport facilities. All kinds of labor, equipment and tools, transportation shall be of the contractor.

In case of failure to comply with the provisions of the terms and conditions mentioned, by agency that has been awarded the contract, the Director ICAR-CSWRI Avikanagar reserves the right to award the contract to the next eligible tenderer and the difference of price will be recovered from the defaulter agency who has been awarded the initial contract and this will be binding on the tenderer.

The Director ICAR-CSWRI Avikanagar does not pledge himself to accept the highest or any tender and reserve to himself the right of accepting the whole or any part of the tender or portion of the quantity offered and tenderer shall execute the work at the rate quoted.

Failure and Termination: If the contractor fails to execute the work within the period prescribed (i.e., within 90 days from work order), the Director ICAR-CSWRI Avikanagar may without prejudice to his right to recover damages for breach of the contract, be entitled at his options:

- i. To recover from the contractor as agreed liquidated damages, a sum equivalent to 5% of the value of the bid which the contractor has failed to perform the work within the period fixed for completion of the work after expiry of the work period, or
- ii. To cancel the contract or a portion thereof, and if so decided to authorize the work not performed by the contractor to any other party/firm at the risk

and cost of the contractor.

Force Majeure: ICAR CSWRI may consider relaxing the requirements, as specified in this document, if and to the extent that, the performance or other failure to perform its obligations under the contract is the result of an Force Majeure. ForceMajeure is defined as an event of effect that cannot reasonably be anticipated such as acts of God (like earthquakes, floods, storms etc.), acts of states, National Agencies, the direct and indirect consequences of wars (declared or undeclared), hostilities, National Emergencies, civil commotion and strikes and successful bidders premises or any other act beyond the control of the bidder.

Jurisdiction: The disputes, legal matters, court matters if any shall be subject to **Malpura jurisdiction only.**

SPECIAL INSTRUCTIONS FOR TENDER

The following special conditions auction for Cutting off / Lopping / Pollarding of Ardu Trees in field, uprooting Israeli acacia and other trees (Neem, Mango, Siras, Ardu etc.) near to buildings, at ICAR- CSWRI, Avikanagar

TERMS AND CONDITIONS:

- i. Work shall be certified as completed subject to satisfactory completion of the work by the Incharge Farm Section / assigned officer.
- ii. The trees have to be pruned / heavy looped as per their height i.e. pruning / heavy lopping above 15 to 20 feet or where 2 or more branches diverge so that the tree sprout/ regrow well.
- iii. Some of the trees have inhabited bee hives. It will be the responsibility of the contractor to safely remove such bee hives. No payment and co-operation will be made by the institute in this regard.
- iv. Those trees above the height of 20 feet and diameter more than 15” will come under the category of lopping of green trees. Before cutting such trees, the contractor will have to mark such trees in consultation with the Sector In-Charge. The contractor shall be liable for punitive action for cutting trees other than such marked trees.
- v. Before loading the pruned /chopped off part of trees into loading vehicle, weight of such loading vehicle shall be measured in unloaded position on institute’s dharamkanta. After loading the pruned /chopped off part of trees, the weight shall be measured again and the full payment of such weight of pruned /chopped off part of trees will have to be made in online mode after which gate pass shall be issued.
- vi. The work site should be maintained cleaned and remained as no hump or pit.
- vii. After cutting off the trees the stub should be removed and cleared from the property.
- viii. The work may be executed through others, at the risks and costs of the contractor and at the discretion of the authority.
- ix. No or any part of the trees should be discarded with the CSWRI compound in any manner.
- x. Work shall be done only on working days and during office hours. No person shall permitted to work before or after the office timing ie (9 Am to 5.30PM).
- xi. No person (s) shall permitted to camp within the compound after the office hour.
- xii. The workers of the contractor shall work in a disciplined manner and the working of the contractor should not affect the smooth functioning of the office in any manner.
- xiii. Accident, if any, occurred within and outside the compound of CSWRI during the time of the work to the workers or public shall be the responsibility of the tenderer itself and CSWRI will not be responsible for any such accidents/losses.

- xviii. The tenderer shall remit the FDT, GST and TDS as applicable.
