Applications are invited for filling-up the following Technical/Skilled Support Staff Posts at Central Sheep & Wool Research Institute, Avikanagar under the control through open competitive examination and interview. The essential and desirable qualifications etc. for each post are given below:-

**General instructions for candidates:-**

- The minimum and maximum age limit is 18-25 Years for Skilled Support Staff and 18-30 years for T-3 (Technical Assistant) and T-1 (Technician).
  - Relaxation in upper age limit will be five years for SC/ST, three years for OBC, 10 years for Physically Handicapped candidates and any other category will be allowed as per the extant rules of the Govt. of India/ICAR issued from time to time.
  - For regularization of casual labourers with temporary status age limit shall be as per DOPT's OM No. 5106/2/90-Estt.(C) dated 10.09.1993, if applied concerned for Skilled Support Staff.
- No age limit for I.C.A.R. employees to Technical posts. For Research Associates / Senior Research Fellows who have been engaged on contractual basis in different ICAR Institutes as on date [cut off date for receipt of duly filled application] are eligible for relaxation in the upper age limit to the extent of their spell, during which they were actually engaged as RAs / SRFs in different projects of ICAR Institutes [maximum of 16 years 03 months]. They should have been engaged continuously in different projects of ICAR Institutes without inordinate spell of breaks. An employment certificate indicating the names of the projects and the exact period he / she worked in each project, may be obtained from the Competent Authority and enclosed along with the application. The applications without Employment

Certificate and authentic proof will not be entertained. The age relaxation is applicable for the posts of T-3 (Technical Assistant) under Direct Recruitment for RAs / SRFs only. This dispensation is only for relaxing the maximum age limit and does not imply any other relaxation whatsoever regarding essential qualifications and experience etc.

3. Last date for receipt of applications is 30 days from the date of publication in Employment News (for applicant posted in Andaman and Nicobar Islands, Lakshdweep, Minicoy and Amindeivi Islands, States/Union Territories in the North-Eastern Region, Ladakh Division of J&K State, Sikkim, Pangi will be 45 days from the date of publication of Advt.). Application received after due date will not be entertained. The Director, CSWRI, Avikanagar reserves the right to cancel the recruitment due to one reason or the other.
4. Mere possession of higher qualification does not entail any right to any candidate for call of examination/interview. Only short listed candidates will be called for interview.
5. Crucial date for determining the age limit of candidates will be the closing date of receipt of applications.
6. Community Certificate for SC/ST/OBC may be obtained from the competent authorities in the latest standard format as prescribed by Govt. of India from time to time.
7. The post is non-government under the Indian Council of Agricultural Research which will be governed by the New Pension Scheme introduced by the Govt. of India with effect from 01.01.2004 mutatis-mutandis and as amended from time-to-time.
8. The posts are purely temporary but likely to continue.
9. The place of posting of selected candidate will be as per their merit at CSWRI, Avikanagar or its sub-stations i.e. SRRC, Mannavanur, Kodaikanal-624 003 (T.N.), NTRS, Garsa-175 141, Kullu (H.P.) and ARC, Bikaner-334 006 (Rajasthan). However, appointee will be liable to serve in any Institute of ICAR anywhere in India
10. The candidates who are in service in the Central/State Govt./ Undertaking / Autonomous bodies etc. should apply through 'proper channel'.
11. The candidate should give declaration in the application form at serial number 10 whether he/she is related / not related to any employee of the CSWRI/ICAR and if so, he/she has to provide the details
12. No TA/ DA is admissible for attending the interview. However, SC / ST candidates will be paid TA only by shortest route as per Govt. of India's Rules.
13. Applications received after the due date for any reason including postal delays will not be entertained.
