Granting of advance increments to technical employees of ICAR consequent to the implementation of recommendations of VII Pay Commission- reg.

Sir/Madam,

Under Rule 6.1 of the ICAR Technical Service Rules, there is a system of merit promotion from one grade to next higher grade irrespective of the occurrence of the vacancies in the higher grade or grant of advance increment in the same grade, on the basis of the assessment of performance.

The Council had solicited the advice of the Department of Expenditure, Ministry of finance regarding the rate at which one advance increment can be granted in view of the implementation of VII CPC, to those technical personnel who are recommended for grant of advance increment by the Assessment Committee, in their grades.

The Department of Expenditure, Ministry of Finance vide its ID Note No. 14-4/2018-E.III(A) dated 19th March, 2018 has advised to revise the existing rate of advance increment by a factor of 2.25 (two point two five), because the factor of 2.57 (two point five seven) is fitment factor only for the purpose of pay fixation. Therefore, the mode of calculating the quantum of advance increment shall be as under:

This will be applicable w.e.f. 01.01.2016 and advance increments already granted in accordance with 6th CPC rates may be revised accordingly. Necessary action may be taken at Institute level.
