About CSWRI-ABI Centre:

CSWRI Agri Business Incubation Centre (ABIC) has been sanctioned by ICAR under the scheme of National Agricultural Innovation Fund (NAIF)-Component II (Incubation Fund) in October 2019. ABIC intends to promote agribusiness and entrepreneurship development with the concept of growth through innovation, upgradation of technology and skill development. This centre envisages facilitating incubation of new start-ups/entrepreneurs for innovative technologies by providing need based physical, technical, business and networking support, facilities and services to test and validate their venture before successful establishment of enterprises. Presently the CSWRI-ABIC is promoting entrepreneurship in the field of commercial sheep, goat and rabbit farming and their post harvest technologies. To accelerate growth in these areas incubation support will be provided through our ABIC to nurture all intended potential agripreneurs.

Visit of scientist(s)/expert(s) will visit to the farm/ workshop of the incubator on request. (TA/DA to born by the incubatee)

Advisory services for Branding, Certification and Marketing.

Intellectual property Rights Cell

Intellectual to help in IP management & commercialization of new products.

Funding

Funding to facilitated through investors, bank loans and other various funding agencies.

Single Window Access

The centre will provide single-window access for all agri-business activities within the institution for consultancy, consortia and incubation encourage associations to lead the projects in the initial stages, meet the specific objectives of mobilising resources, obtaining finance, transferring risk and performing specific investment activities.

Focus areas for start-ups, entrepreneurs and innovators

- Seed technology on sheep/goat/rabbit and cenchrus grass
